- 4) The discount at Warwick's is for Reading Group members and program books only. It is not to be shared with others or used on personal purchases outside the scope of Reading Group program.
- 5) If your employment status changes while in this program, you may continue as long as you have attended the first session and intend to remain in the social sector.
- 6) The work of the Fieldstone Leadership Network includes taking pictures of our leadership programs and participants and our involvement with the community. As a partner with us and a participant in our various programs, you acknowledge that your image may appear in our photographs and videos.
